Membership transfer is restricted by certain provisions. A membership should not be viewed or acquired as an investment, and no person acquiring a membership should expect to derive any economic benefit from the purchase of a membership. **III. PAYMENT OF DUES, FEES AND CHARGES**

I hereby acknowledge that all dues and any fees and charges will be billed directly to my Club Account. I understand that my Club Account shall be considered delinquent if not paid within 30 days after the date of the monthly statement and will be subject to a late payment charge equal to the lesser of (i) a one and one-half percent (1.5%) per month, or (ii) the maximum amount that may be contracted for, taken, reserved, charged, or received under law. This late charge shall accrue from the date of the monthly statement until the account is paid in full. I acknowledge that the Club may take whatever action it deems necessary to effect collection, including without limitation, suspension or termination of my membership or legal action. I acknowledge that I shall be liable for all costs and for any expenses of such legal action and reasonable attorneys' fees.
